

Outcomes

Sexual Re-offending

201 Youth who attended the program were studied by an independent research team at the University of Nebraska.

The youth's offending was reviewed for an average of 7.2 years after discharge, using comprehensive crime databases.

92% of youth who attended the Whitehall program were never charged with another sexual offense during this follow-up time period.

Immediate Outcomes

Whitehall provides monthly updates to address the following with each youth and family: risk reduction, social skill development, aggression replacement, family functioning, and readiness for discharge

Educational Outcomes

Youth who enter the program are often behind in school credits and by discharge often leave the program at grade level or above.

Community Service

Youth are involved in community service through the Whitehall program.

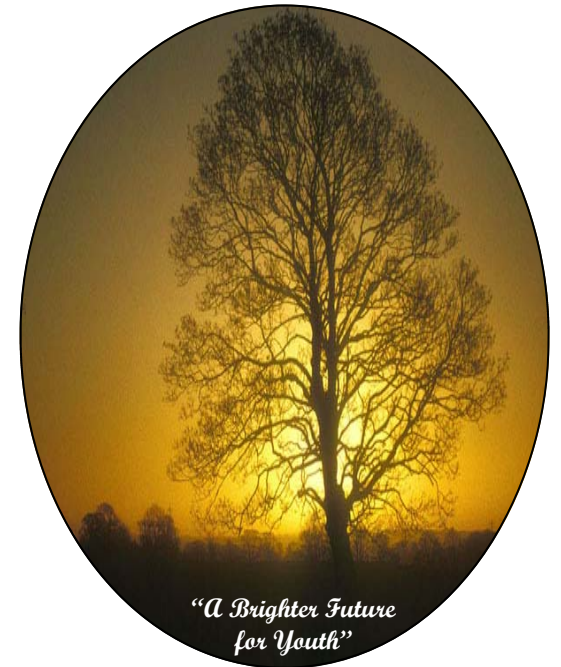

The living room provides a comfortable environment for studying, leisure activities, and group therapy.

The Whitehall program assesses, treats, and successfully re-engages youth with their families and communities. Our program uses progressive, evidence based practice for adolescent males who have engaged in sexual offenses.

Professional Services

Diagnosis and treatment planning are developed with input from an interdisciplinary team that includes,

- Psychiatry
- Psychology
- Nursing service
- Therapists
- Therapeutic Recreation
- Youth Security Specialists
- Primary Care Physician
- Education and Special Education Services
- Chemical Dependency Counselor
- Dietary
- Telehealth over secure service

The treatment team works with the youth, family, guardians, case manager, and court personnel to develop an individualized treatment plan. The treatment plan is implemented by members of the interdisciplinary team who have frequent contact with the youth throughout the day.

Admission Criteria

For Community Residential Program

- Youth are 13 to 18 years of age
- Youth have been through adjudication and sexual offending behavior has been identified as a primary problem with high or high to moderate risk for re-offending
- Youth require 24 hour awake supervision
- No immediate high risk for suicidal activity, elopement, physical aggression, or need for inpatient psychiatric hospitalization

All admissions are preplanned and not done on an emergency basis.

Treatment Setting

- 3 Residential Cottages, with up to 8 youth in a cottage
- Each youth has his own room
- Cottages have an electronic security system and 24 hour awake staff supervision
- Youth attend Morton School which is located on the campus.
- Youth can attend religious services in the community, with staff supervision
- Family visitation is available on campus, and when ready, the youth and family can go on community outings (e.g., meal, shopping).

Interventions

- Family therapy four times a month
- Parenting skills training
- Treatment of trauma
- Treatment of attachment issues
- Treatment of abuse and neglect issues
- Development and use of safety plans
- Development of social skills
- Development of healthy sexual boundaries
- Anger management training
- Moral reasoning training
- Cognitive restructuring
- Treatment of alcohol and other drug abuse issues
- Development of impulse regulation skills
- Special education services
- Development of healthy leisure skills
- Work and independent living skills
- Practice the use of safety plans in the community under staff supervision
- Medical, dental, and vision services

Licensing

The Whitehall program is licensed and accredited as part of the Lincoln Regional Center.

Morton School is an approved Rule 18 School under the Nebraska Department of Education.
